# DOUBLE DEGREE PROGRAMMES WITH SHIH CHIEN UNIVERSITY I.



The programme will be operated in accordance with the Bachelor Programme in International Business of the College of Management of USC and BA in International Business Economics of BBS Faculty of International Management and Business.



**Language skills requirements:** at least TOEFL 550, on-line TOEFL 220, TOEFL Ibt 71, CER B2, IELTS 6.0, TOEIC 750 or equivalent.



Double degree students will also be registered as students of the partner institution. Each institution will accept **without tuition fees** the students selected and nominated by the partner institution.



# DOUBLE DEGREE PROGRAMMES WITH SHIH CHIEN UNIVERSITY II.



Taiwanese students studying on the English double degree programme will have to collect 70 credits in two semesters, according to the ECTS system applied in Hungary



Hungarian students who study on the double degree programme of the Taiwanese institution will have to collect 43 credits during their studies (2 semesters) according to the Taiwan grading system.



Double degree students will secure international internship complying with the placement requirements of both institutions.



# DOUBLE DEGREE PROGRAMMES WITH SHIH CHIEN UNIVERSITY III.



The first students (2 of USC, 2 of BBS) started their studies at the partner university.



# CONCLUSIONS

- ↳ Double degree cooperation can be planned and organized within 3-6 months. A new accreditation process isn't necessary.
- ↳ Double degree agreements are important elements of the internationalisation process of HEIs.
- ↳ Double degree can be a first and important step towards a joint degree construction.



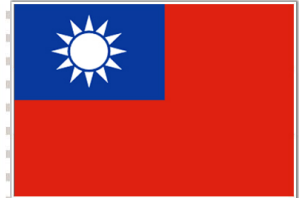
# FUTURE PLANS
